Green Acres Fuel will sell and deliver to the address shown on this acceptance, your entire requirement of heating oil, subject to any governmental regulations or requisitions, from the date hereof until Green Acres Fuel shall receive in writing a request from you (the customer) to withdraw from this contract, or Green Acres Fuel notifies you (the customer) of discontinuance or transfer of automatic delivery service.

**Pricing:** Subject to a prepaid balance of fuel, the price per gallon shall be Green Acres Fuel's prevailing market price for the place of delivery at the time each delivery ticket is scheduled for delivery (up to three days in advance of delivery), plus all taxes & surcharges, through tank hose connection.

**Terms:** Payment is due on delivery by check, cash, or credit card (debit cards not accepted). If customer is not available to pay at time of delivery, an invoice will be left and customer may send payment by check within five days of delivery. If payment has not been received within seven days of delivery, the balance due will automatically be charged to the credit card on file. A 2% convenience fee will apply to all credit card transactions. Returned checks are subject to a \$70 dollar charge. Customer is responsible for all interest charges & bill collection fees that will be assessed by Green Acres Fuel on delinquent accounts. Delinquent accounts will not receive further deliveries until past invoices & fees have been paid in full. The customer agrees to provide and maintain suitable storage with outside connections that perform properly according to modern industry standards as well as unimpaired access thereto by tank truck at all times at his/her entire cost & risk. Failure to maintain access to fill may result in additional charges being assessed. Customer agrees to defend and hold harmless Green Acres Fuel and any affiliates or related parties from any claims arising from or related to (to any extent) improperly or poorly configured or poorly maintained tanks or connections. Green Acres Fuel shall not be liable for damage of any kind to customer's property, driveway, etc. In no case shall any liability be incurred by Green Acres Fuel for failure to deliver fuel for any reason. This offer, and its acceptance as evidenced by your completion of this form, will, when received by us, constitute the entire contract between us and shall be considered personal, and subject only to written modification or change.
